- 2. The questions in both the papers shall be objective type questions with multiple choice answers. The answer sheets shall be evaluated through OPTICAL MARK READING (OMR) process.
- 3. Eligibility for admission to Preliminary Test is
 - Sr. Auditor / Auditor / Clerks/ Typists /DEOs /Stenographers /Hindi Translators and Librarians are eligible for appearing.
 - Candidates must have to put two years service (including continuous temporary service) in any of the grades in the Department as on the fist of the

- month in which the examination is held i.e., 01.04.2016 provided that the candidate must have cleared probation period.
- Candidates who have qualified last Preliminary Examination (Test) held in June, 2014 but absented or withdrawn their candidature from appearing in SAS Part – I Examination held in September, 2014 will be required to re-qualify in the Preliminary Examination (Test).
- SAS Apprentices are exempted from appearing in Preliminary Examination.
- As per SAS Rule 6 and 14 (b), the maximum chances for appearing SAS Part I & II examination will be only Four for each part. Additional chances may be permitted by the CGDA as per merit of each case. Hence, a candidate who has availed four maximum chances for SAS Part I examination after qualifying Preliminary Examination held in June, 2007 and September, 2008, are not eligible to appear again Preliminary Examination (Test) April, 2016 for getting further chances.
- The Candidates who have failed to qualify the Preliminary Examination held in past i.e., June 2007, Sept 2008, Aug 2012 and June 2014 or not appeared in Preliminary examination (Test) so far would be eligible to appear.
- 4. In case of disclosure of any wrong/incorrect information regarding eligibility criteria, on later stage, the individual will be disqualified from the examination and benefit if any awarded consequent on passing of the examination would be taken back without assigning any further reason and without prejudice to such further action as may be taken under the provisions of the law for giving false information.
- 5. The examination will be conducted at Allahabad, Bangalore, Chandigarh, Cochin, Chennai, Dehradun, Gawahati, Jaipur, Jammu, Jabalpur, Kanpur, Kolkata, Lucknow, Meerut, Mumbai, New Delhi, Patna, Port Blair, Pune-A [PCDA(O)], Secunderabad. The centers are subject to change depending on administrative convenience. The Centre of Examination will be the nearest to the duty point of the candidate. In case, candidate desires to take examination at a centre other than the nearest to duty point, an application has to be submitted with specific reasons.
- 6. In case a physically handicapped candidate is desirous of facility of scribe/compensation time etc., application along with requisite medical certificate may be submitted.
- 7. CGDA has decided to lower/relax the qualifying standards for SC/ST candidates appearing in this examination upto a maximum extent of 5% in individual paper/aggregate.
- 8. The interested candidates are requested to give their willingness in the enclosed proforma positively by **01.02.2016**
